MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objective and Strategies

The investment objective of the Fund is to achieve capital appreciation and dividend income by investing in equity securities of issuers around the globe. The Fund is diversified across the full market capitalization spectrum, by sector and by region, including emerging markets. The Fund will seek to invest in high-yielding equities with a focus on total return and not purely on dividend yield.

The portfolio sub-advisor in respect of this Fund, Lazard Asset Management (Canada) Inc., has retained Lazard Asset Management LLC ("Lazard") as its sub-advisor, which employs a team-based approach in the management of the Fund. Lazard's strategy is founded on the philosophy that an understanding of the current economic environment can be coupled with research into the drivers of (and risk to) outperformance to create a portfolio aligned with the current economic cycle.

Risk

As an investor in this Fund, you should be prepared for short-term performance fluctuations, and be a patient, long-term holder.

There were no significant changes to the level or type of risk you would expect from the Fund over the course of the year. It continues to have a medium risk level. Refer to the Fund's simplified prospectus for a complete list of all risks.

Results of Operations from January 1, 2017 to December 31, 2017

Markets & Effect

Global stocks performed well in 2017, as global growth accelerated and became more synchronized, while inflation and interest rates remained subdued, enabling equity valuation multiples to continue to expand. While late 2016 saw a dramatic rotation from defensive growth stocks toward more attractively valued cyclicals as deflationary pressures abated, 2017 saw investors shun valuation once again in favor of defensive growth stocks. Weakness in oil prices early in the year and the lack of uplift in US wage growth, even as unemployment fell to multi-decade lows, led investors to lose hope for a normalization in inflation and interest rates. Valuation-oriented strategies, which typically outperform in environments of building inflationary pressures, struggled during the year. Investors focused on a handful of perceived winners that offered sufficient defensiveness or secular growth to maintain profitability in an adverse environment, driving significant outperformance of high momentum stocks. The technology sector materially outperformed, driven by higher growth companies in areas such as social media. Meanwhile, lower-valued sectors, such as telecommunications and energy, lagged significantly. The energy sector's underperformance occurred in spite of the more than 40% increase in the price of West Texas Intermediate crude oil during the second half of the year.

Performance

The Fund's Unhedged Series A units trailed its benchmark, gaining 7.9% versus a gain of 15.9% for the MSCI All Country World Index (the "Index"). The Fund's Hedged Series A units also trailed its benchmark, gaining 10.4% versus a gain of 19.6% for the MSCI All Country World Index Hedged (the "Index").

The Fund returns are after the deduction of fees and expenses while the benchmark returns do not include any costs of investing. See the "Past Performance" section for the

returns of the other series, which may vary because of differences in management fees and expenses or timing of series introduction.

Holdings in oil, gas & consumable fuels made positive contributions to overall performance, while an underweight to internet software & services was a detractor from relative performance during the period. Holdings in Taiwan contributed to performance, while holdings in the United States detracted from relative performance during the period.

Asset Mix

At December 31, 2017, equities made up 98.3% of the Fund, and 1.7% was in cash and other net assets.

The Fund's most significant industry exposure change was a decrease in holdings in diversified telecommunications services to 2.3% from 10.3% at December 31, 2016.

Flows & Fees

The Fund's Net Asset Value decreased to \$112.1 million at December 31, 2017, from \$132.1 million at December 31, 2016. Of this change, an increase of \$10.0 million was due to positive investment performance (net of investment income), and a decrease of \$30.0 million was due to outflows.

For Series A units, the annualized management expense ratio ("MER") at December 31, 2017 is 2.63%, compared to 2.64% at December 31, 2016 for the Unhedged Series. The annualized MER for the Hedged series is 2.75% at December 31, 2017, compared to 2.74% at December 31, 2016.

Recent Developments

There are no known changes at this time to the strategic positioning of the Fund, the manager, or portfolio sub-advisor.

On July 7, 2017, Bridgehouse re-designated current investors in Series K to Series A, Series L to Series A, Series M to Series F and eliminated Series K, Series L and Series M. In anticipation of the Series re-designations, Series K, Series L and Series M were closed to new purchases as of July 4, 2017.

International Financial Reporting Standards

IFRS 9, "Financial Instruments" ("IFRS 9")—The International Accounting Standards Board (IASB) issued IFRS 9 to replace IAS 39, "Financial Instruments—Recognition and Measurement". IFRS 9 introduces a model for classification and measurement, a single, forward-looking 'expected loss' impairment model and a substantially reformed approach to hedge accounting. The new single, principle based approach for determining the classification of financial assets is driven by cash flow characteristics and the business model in which an asset is

held. The new model also results in a single impairment model being applied to all financial instruments, which will require more timely recognition of expected credit losses. It also includes changes in respect of own credit risk in measuring liabilities elected to be measured at fair value, so that gains caused by the deterioration of an entity's own credit risk on such liabilities are no longer recognized in profit or loss.

The new standard is effective for the Fund's for its fiscal year beginning January 1, 2018. On adoption of IFRS 9 the Fund's investment portfolio will continue to be classified as fair value through profit or loss. Other financial assets which are held for collection will continue to be measured at amortised cost with no material impact expected from application of the new impairment model. As a result, the adoption of IFRS 9 is not expected to have a material impact on the Fund's financial statements."

Related Party Transactions

Manager and Portfolio Advisor

The Fund is managed and advised by Brandes Investment Partners & Co., operating as Bridgehouse Asset Managers ("Bridgehouse") which provides (or arranges for) investment management, distribution, marketing and promotion of the Fund. Bridgehouse receives a monthly management fee based on the daily average net assets of each class of the Fund. In addition, Bridgehouse is entitled to be reimbursed by the Fund for certain operating expenses.

Bridgehouse has retained Lazard Asset Management (Canada), Inc. who has retained Lazard Asset Management LLC, ("Lazard") as the portfolio sub-advisor in respect of the Fund. Bridgehouse pays Lazard an investment management fee to provide the Fund with investment management services.

- The management expense ratio ("MER") is calculated as the total management fees and operating expenses paid by each series of the Fund, including GST/HST and interest and excluding commissions and other portfolio transaction costs, and is expressed as a percentage of the average daily Net Asset Value of each series of the Fund on an annualized basis. Any management fee distributions paid by a series of the fund that effectively reduced management fees payable by some unitholders are not deducted from expenses to determine the overall MER of that series. The Manager, at its sole discretion, waives management fees or absorbs expenses. Such waivers and absorptions can be terminated at any time. The MERs of the Fund are shown both with and without the waiver and absorptions.
- Portfolio turnover rate is calculated at the Fund level based on the lesser of purchases or proceeds of sales of securities for the period, excluding cash, short term notes and bonds having maturity dates at acquisition of one year or less, divided by the average value of the portfolio securities for the period. The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a Fund.
- The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average Net Asset Value of the Fund. The trading expense ratio is calculated at the Fund level and applies to all series of the Fund.

MANAGEMENT FEES

Bridgehouse Asset Managers, the Manager, provides or arranges for investment management, distribution, marketing and promotion of the Fund. In consideration for the services provided, Bridgehouse Asset Managers receives a monthly management fee based on the daily average Net Asset Value of Series A, Series AH, Series F and Series FH. Management fees for Series I and Series IH are negotiated and paid directly by the unitholders of Series I and Series IH, not by the Fund.

For the year ended December 31, 2017, the Fund paid Bridgehouse Asset Managers management fees of \$2,436,427. Bridgehouse uses these management fees to pay for commission payments to registered brokers and dealers and general investment management expenses. The breakdown (commission payments / investment management, administration and other) as a proportion of the management fee for each Series are:

- Series A, AH (40% / 60%)
- Series F, FH (0% / 100%)
- Series I, IH (0% / 100%)

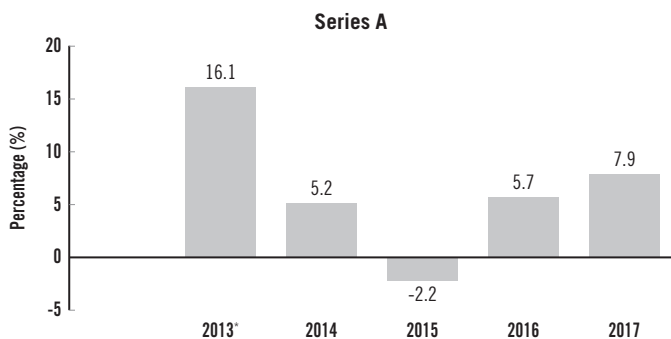
Commission payments represent cash commissions paid by Bridgehouse Asset Managers to registered brokers and dealers during the period and includes upfront deferred sales charge and trailing commissions. This amount may, in certain circumstances, exceed 100% of the fees earned by the Bridgehouse Asset Managers during the period. For new Funds or Series the amount presented may not be indicative of longer term operating periods.

PAST PERFORMANCE

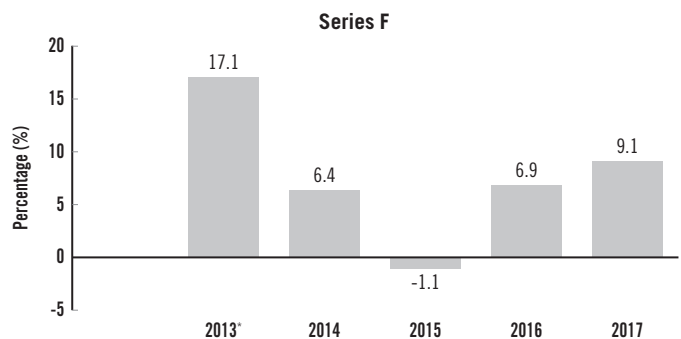

Year-by-Year Returns (%)

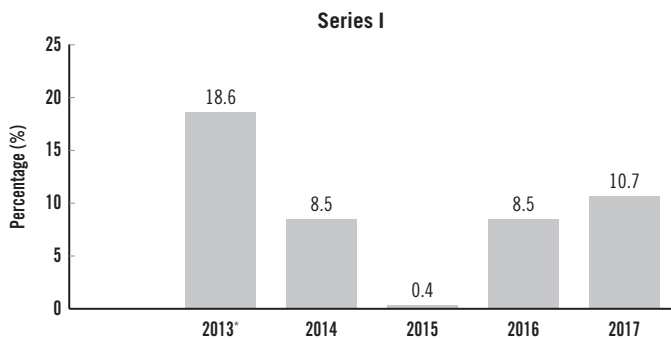

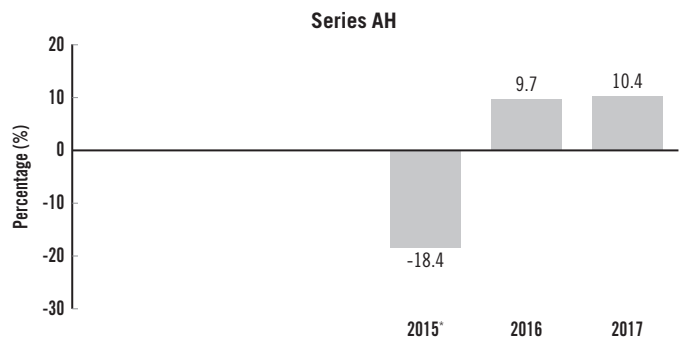

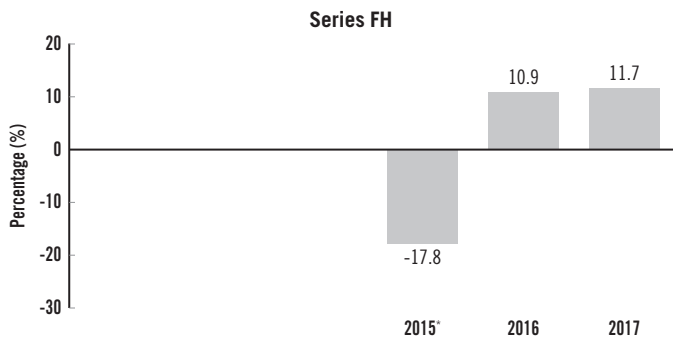

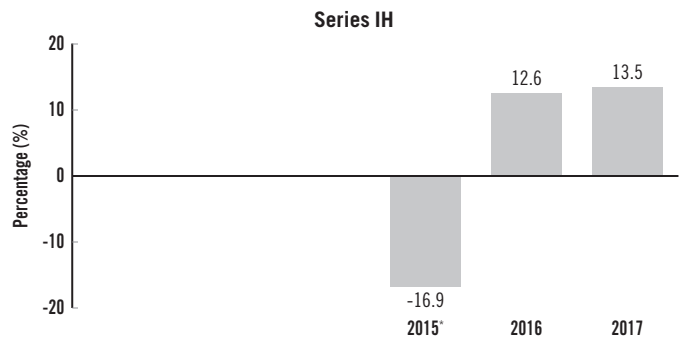
