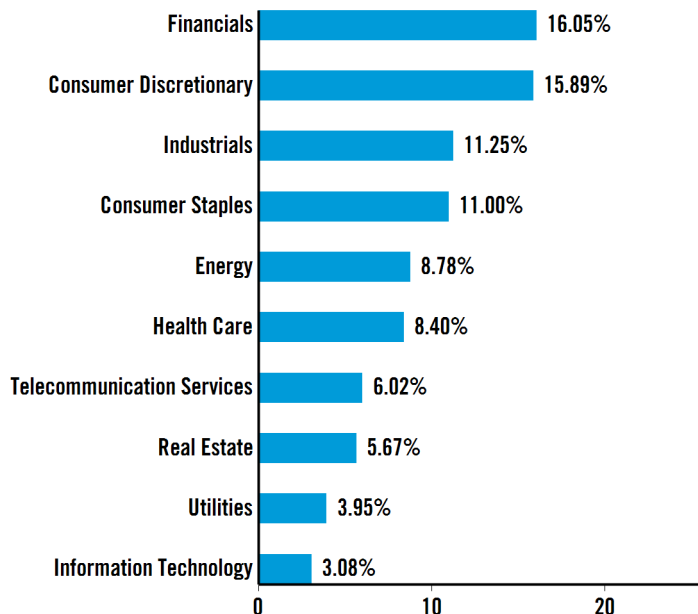

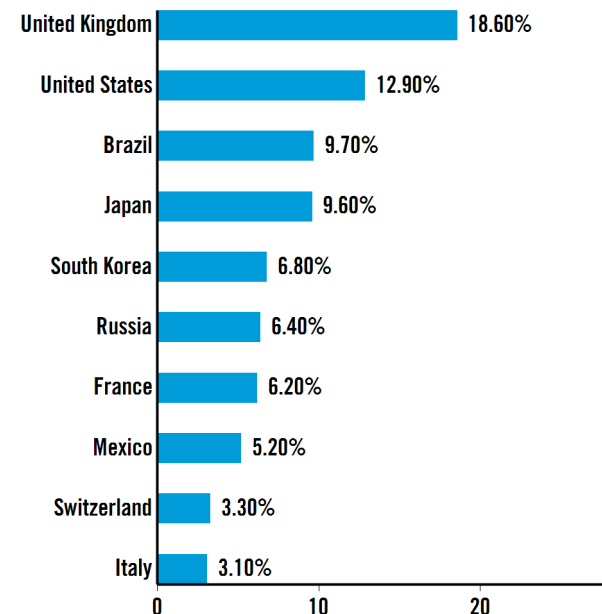

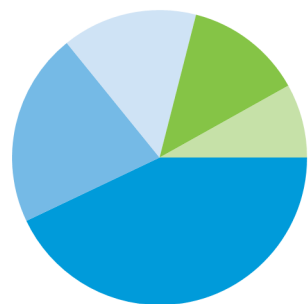
## Sector Exposure (% Equity)

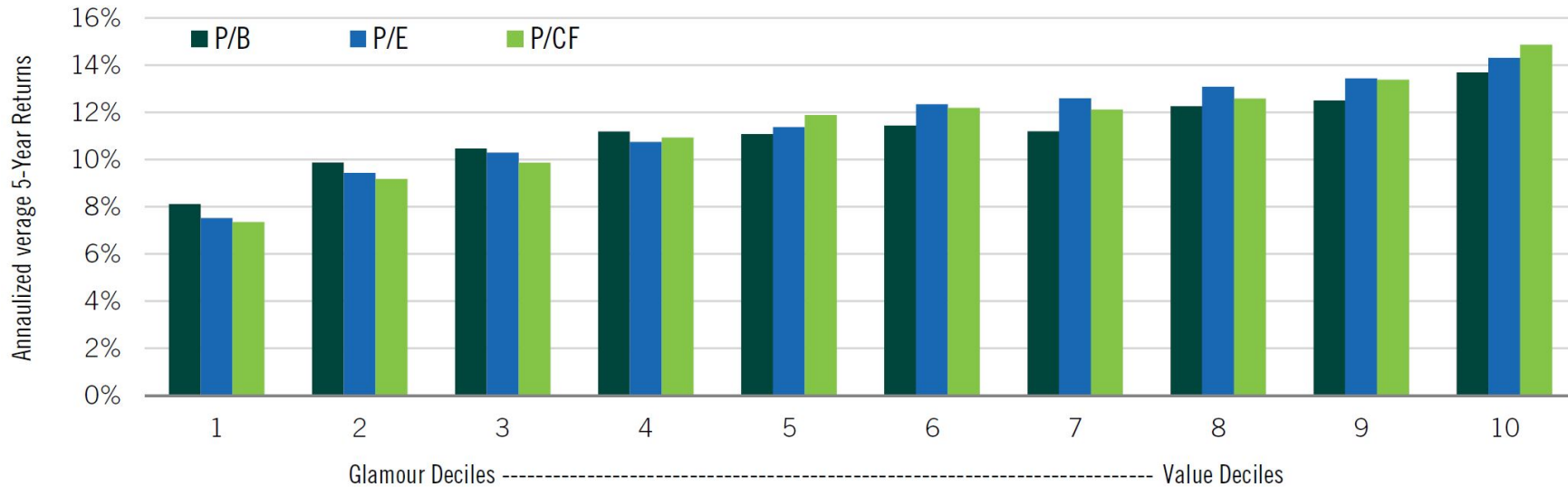

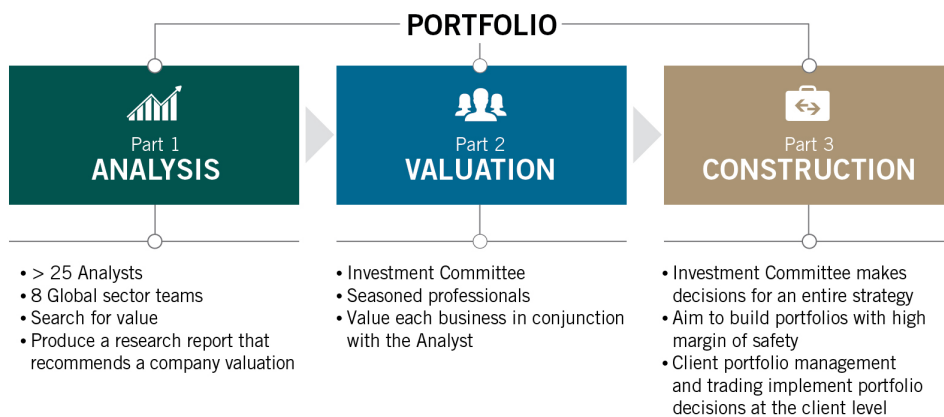
