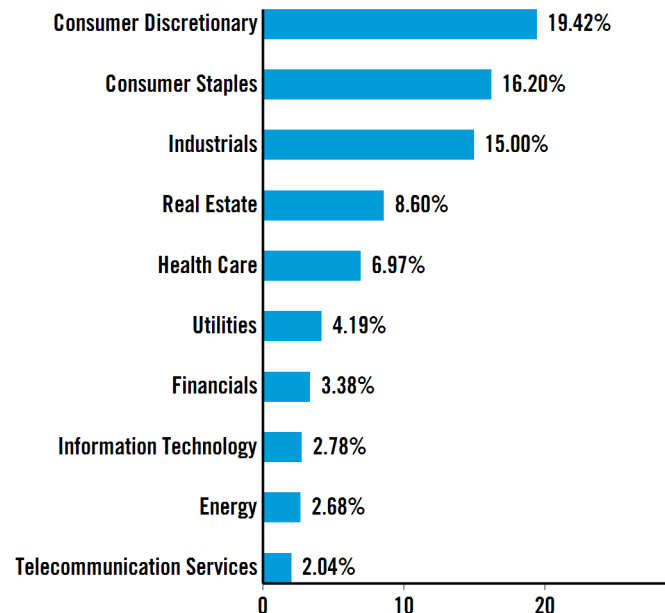

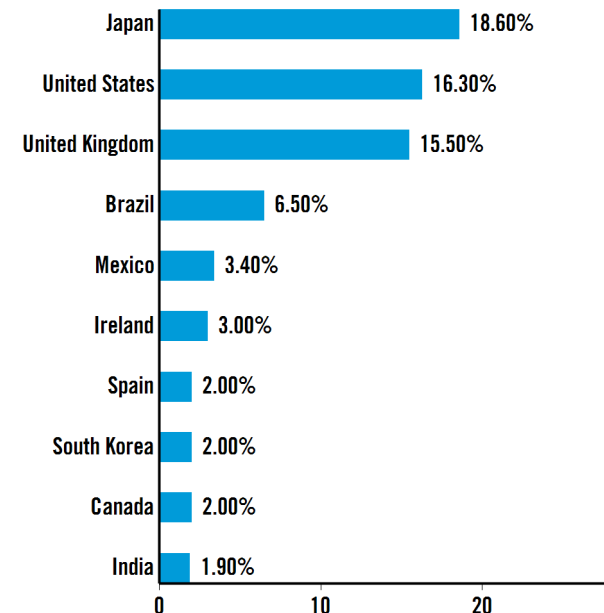

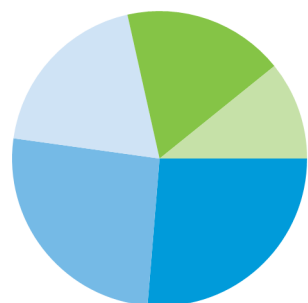
Sector Exposure (% Equity)

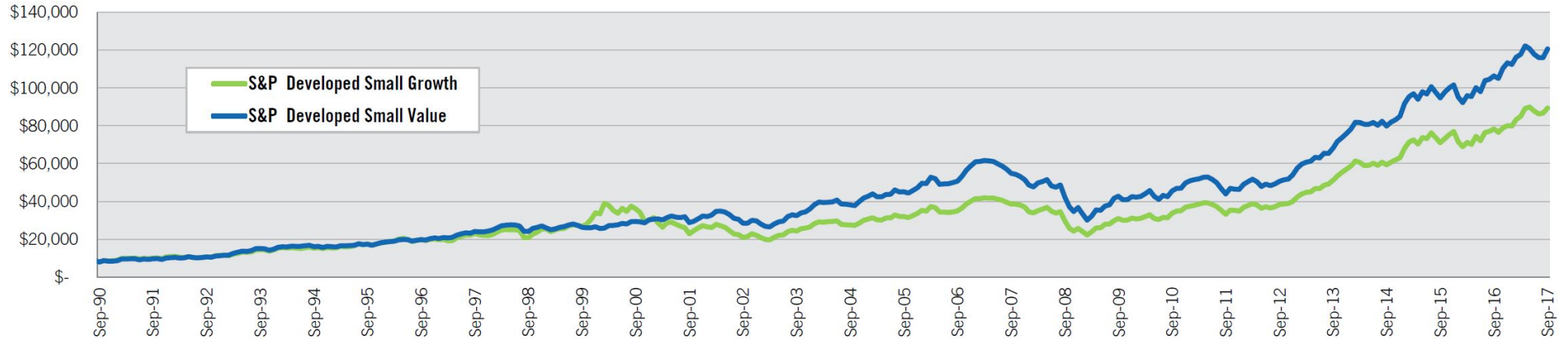

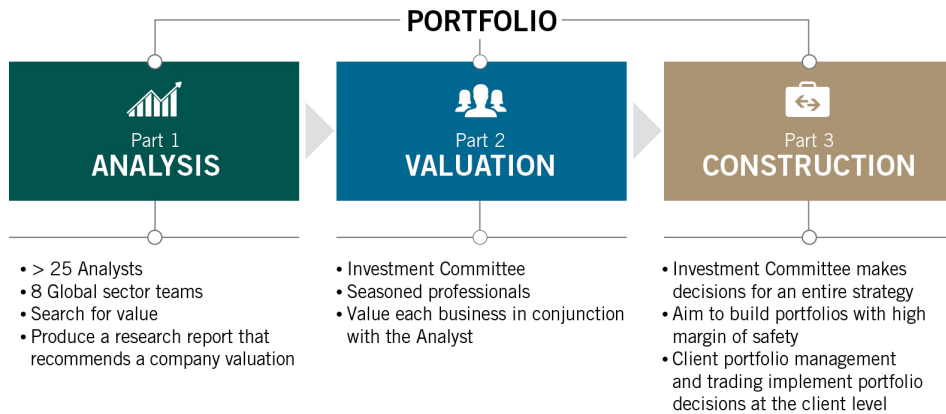
