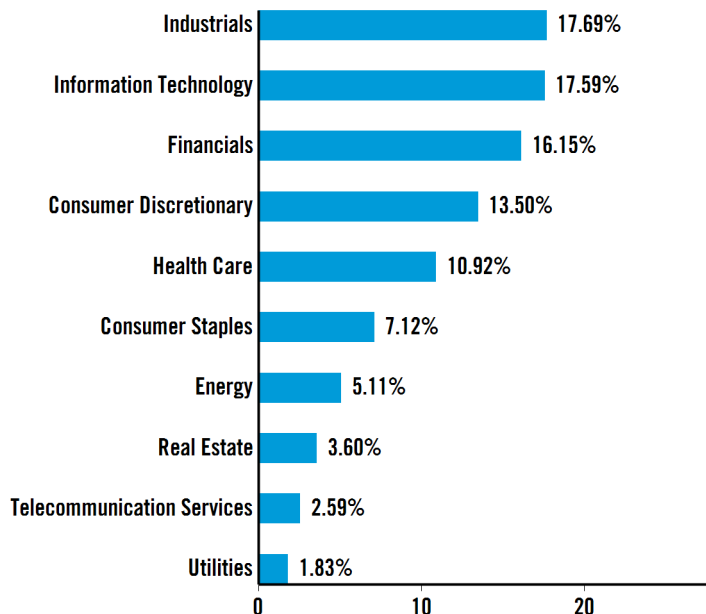

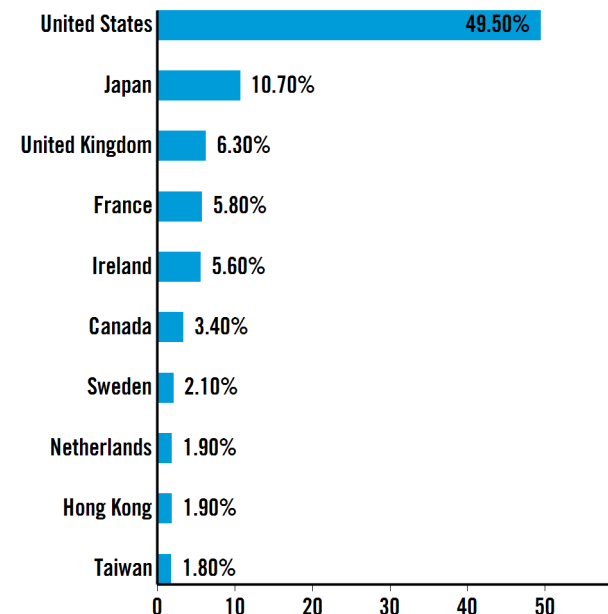

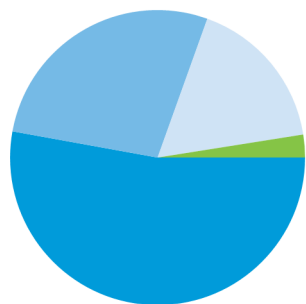
Sector Exposure (% Equity)

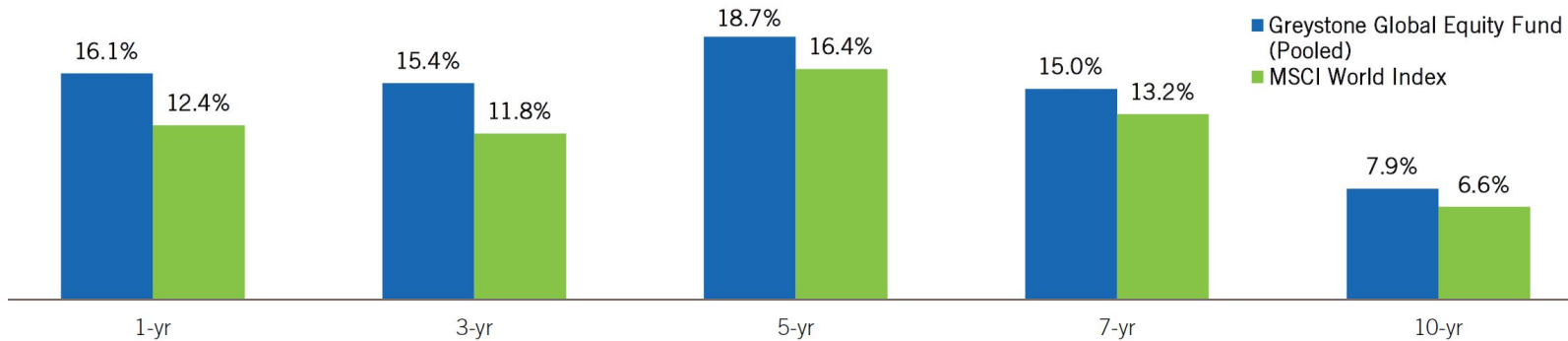

Greystone Global Equity Fund (Pooled) v.s MSCI World Index²

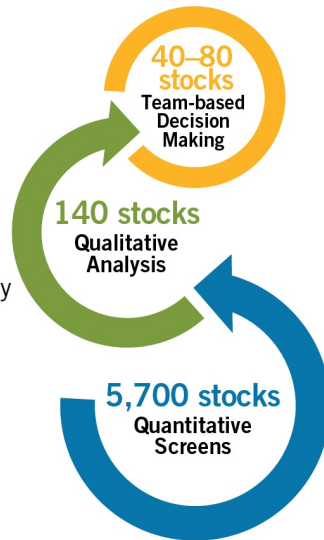
