Aims to give you greater peace of mind about your financial future through:

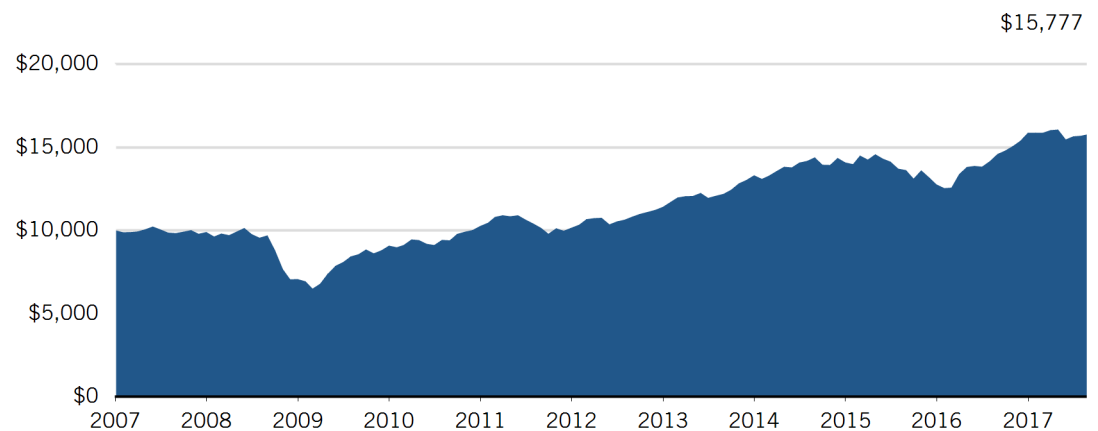

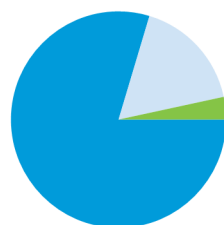
