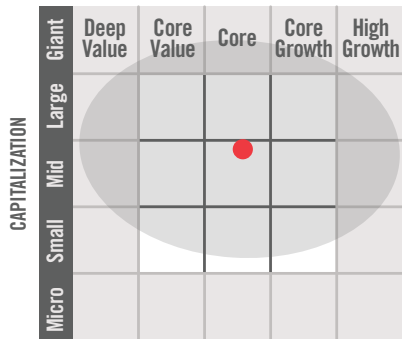

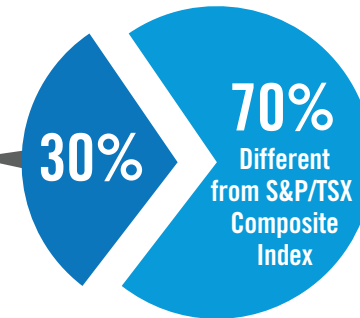

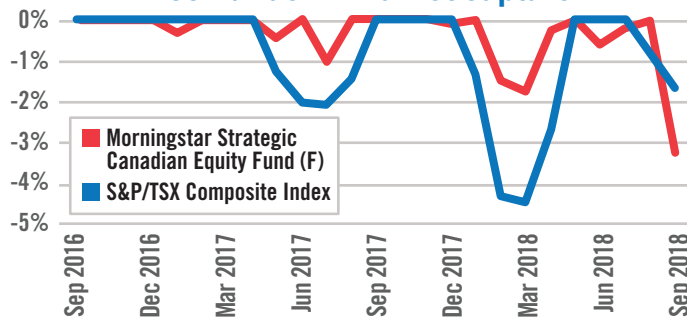

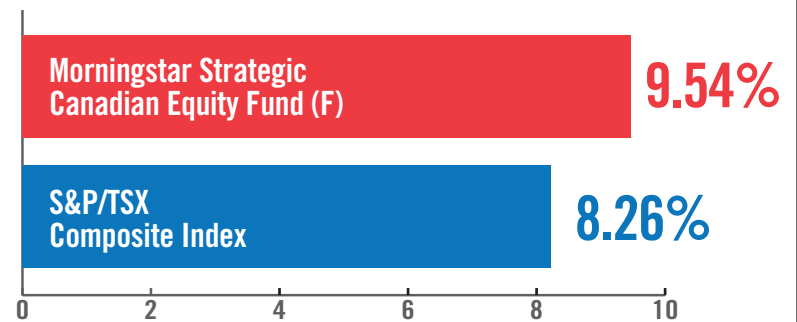
Drawdown Analysis (Oct 2016 to Sep 2018)

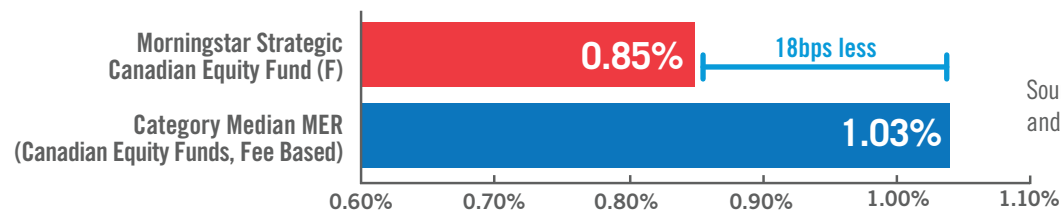

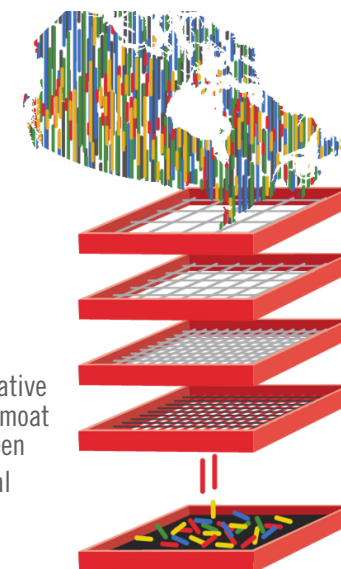
